1. The Ministry of water and Environment -Water and Sanitation Development Facility - Central has received funds from Government of the Republic of Uganda to be used for **the above mentioned procurement**
2. The Entity invites sealed bids from eligible bidders for the (i) **Supply of Agricultural Inputs for Small Scale Irrigation Systems in the Central Districts of Uganda Under Framework Contract.**
(ii) **Supply and Installation of Irrigation Kits on Small Scale Irrigation Schemes in the Central Districts of Uganda under framework contract**
3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 as amended, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00am to 5:00pm on working days.
5. The Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX: 100,000 (Uganda Shillings One Hundred Thousand Only) for each category.** The method of payment will be through the bank
6. Bids must be delivered to the address below at 8(c) at or before **11:00 Am on 2nd March, 2021.** All bids must be accompanied with a **bid security of UGX: 2,000,000/= (Uganda Shillings, Two Million only) for Supply of Agricultural Inputs for Small Scale Irrigation Systems in the Central Districts of Uganda Under Framework Contract and UGX: 5,500,000/= (Uganda**

Shillings, Five Million Five Hundred Thousand only) for Supply and Installation of Irrigation Kits on Small Scale Irrigation Schemes in the Central Districts of Uganda under framework contract
