The Republic of Uganda has received a loan from the World Bank towards the cost of the Integrated Water Management and Development Project and it intends to apply part of the proceeds of this loan to payments under the contract for Civil Works for Installation of Hydrometric Equipment under Categories I, II, & III.
- **2.** The Ministry of Water and Environment now invites sealed Bids from eligible Bidders for Civil Works for Installation of Hydrometric Equipment as detailed below;

Bidding will be conducted through the National Competitive Bidding procedures using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers Procurement in Investment Projects Financing" (July 2016, revised November 2017 and August 2018) and is open to all eligible bidders as defined in the Procurement Regulations.

- 5. The Bidding Documents in English may be purchased by interested bidders for a non-refundable fee of Uganda Shillings One Hundred Thousand Only (UGX 100,000) prior to submission date. Bids <u>MUST</u> be submitted with evidence of purchase of the bidding documents for **Civil Works for Installation of Hydrometric Equipment**. Evidence of payment shall first be verified by the responsible officer in Ministry of Water and Environment at time of submission. The method of payment will be by Bank Payment

- 7. All bids must be accompanied by a Bid Security of **UGX 15,000,000**. For Bid Securities issued by financial institution located outside the Employer's Country, the issuing financial institution shall have a correspondent financial institution located in the Employer's Country to make it enforceable.
