The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 100,000/= (One Hundred Thousand Uganda Shillings) for each subject/ category** The money will be paid to the bank with Bank slips obtained from the Ministry of Water and Environment, Water and Sanitation Development Facility- Central Accounts section. No cash will be accepted.
6. Bids must be delivered to the address below at 8(c) at or before 11:00am on **2<sup>nd</sup> March, 2021**. Late bids shall be rejected.
- Bid securities in form of a bank guarantee must be valid until **28<sup>th</sup> September, 2021**. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below at 8(d) at **11:30am on 2<sup>nd</sup> March 2021**.
